- Happenings at the shelter, Shanna:
 - Outstanding bill for animals in custody. Larry Bierke said that the county is amending its budget and we should
 receive the payment near the end of the year. We still have one protective custody dog until March. We will
 continue to bill for that dog's care. We will negotiate a contract with the county for future protective custody
 holds. The county has been nice to work with.
 - We have 23 of the municipal contracts back two are "nos". The town of Linden requested that Shanna come to their town meeting. She did - discussion concerned feral cats. Shanna will follow up that those that did not respond.
 - Cat flooring: J & C measured all the rooms including the flooring under the holding kennels for the dogs and the flooring in the entryway.
